IMAGE LIBRARY Reproduction Terms and Conditions

1. The Blenheim Palace Image Library is a service provided by Blenheim Palace Heritage Foundation.
2. In attaching the “Blenheim Palace Image Library Licence Summary Document” (referred to herein as “Licence Summary Document”), Blenheim Palace agrees to grant a non-exclusive image reproduction licence as detailed on that document.
3. This licence automatically revokes any licence previously granted to the individual / organisation named on the Licence Summary Document for the reproduction of the same image in the same product detailed on that document.
4. The holder of this licence will not reproduce or distribute the image (or derivatives thereof) in any way, including electronically, except as stated on the Licence Summary document.
5. For the image to be reproduced and/or distributed in any form except as detailed on the Licence Summary Document, a written agreement must be reached with Blenheim Palace Retail.
6. The holder of this licence will give to Blenheim Palace a free-of-charge copy of the product in which the image is reproduced, unless agreed otherwise in writing.
7. The holder of this licence will give credit to both the Blenheim Palace Image Library and to the copyright holder where appropriate, as detailed below:
 - a . When credit is given under or alongside the reproduced image, the credit will read “Blenheim Palace / [PHOTOGRAPHER]”.
 - b . When credit is given at the end of the product, (i.e. acknowledgements page in a book), the credit will read “Photograph by [PHOTOGRAPHER] reproduced with the kind permission of Blenheim Palace Heritage Foundation”.
 - c . If credit is given in any form other than detailed in sections 5a and 5b of this document, this must be agreed in writing by Blenheim Palace.
8. The holder of this licence will notify Blenheim Palace of any proposed changes to the agreed use of the image prior to the changed use taking place, and this must be agreed in writing by Blenheim Palace Retail. Any such proposed changes may result in an adjustment to the original reproduction fee.
9. If the conditions of this licence are breached in any way, Blenheim Palace Retail reserves the right to revoke the licence with immediate effect, and if necessary will

seek compensation through the legal process. No refund will be given upon revocation of the licence.

10. This licence shall be governed by the laws of the United Kingdom.
